VISIT OF A DELEGATION OF THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES TO THE UNITED STATES OF AMERICA

The Court of Justice of the European Communities paid an official visit to the United States of America from Sunday 18 February to Friday 23 February. The delegation was led by Mr Vassilios Skouris, President of the Court of Justice, and was composed of Mr Peter Jann, Mr Christiaan W. A. Timmermans, Mr Allan Rosas and Mr Koen Lenaerts, Presidents of Chamber, Mrs Juliane Kokott, First Advocate General, Mr Endre Juhász and Mr Ján Klučka, Presidents of Chamber, Mr Miguel Poiares Maduro, Advocate General and Sir Konrad Schiemann, Judge.

The delegation visited Washington D.C. where they were welcomed by Chief Justice John Roberts of the United States Supreme Court. In Washington the delegation attended a case at the Supreme Court and held a number of discussions with Justices of the Supreme Court on various subjects of mutual interest.

The delegation held further discussions with the Chief Judge and members of Federal Court of Appeals for the Federal Circuit and with the Court of Appeals for the District of Columbia Circuit

During the visit the delegation also met with Chief Justice Wallace Jefferson and Members of the Texas Supreme Court in Dallas and participated with them in a number of discussions at the SMU Dedman School of Law.

The visit took place in the context of the constant and close relations which the Court of Justice enjoys with the United States Supreme Court. The Court first visited the United States in 2000 and welcomed delegations from the United States Supreme Court in 1998 and 2003.
