Formal sitting of the Court of Justice

Entry into office of new Members at the Court of Justice and the General Court of the European Union

By decision of 7 September 2016, the representatives of the Governments of the Member States appointed Mr Evgeni Tanchev as Advocate General at the Court of Justice for the period from 19 September 2016 to 6 October 2021.

In the context of the partial renewal of the General Court, the representatives of the Governments of the Member States appointed, by decisions of 23 March 2016 and 7 September 2016, Mr Ricardo da Silva Passos, Mr Paul Nihoul, Mr Barna Berke, Mr Ulf Christophe Öberg, Ms Octavia Spineanu-Matei and Ms Krystyna Kowalik-Bańczyk as Judges at the General Court for the period from 19 September 2016 to 31 August 2022.

In the context of the reform of the judicial structure of the Court of Justice of the European Union, the representatives of the Governments of the Member States appointed as Judges at the General Court, by decision of 7 September 2016, Mr Ezio Perillo, Mr Jan Passer and Mr Alexander Kornezov for the period from 19 September 2016 to 31 August 2019, and Mr René Barents, Mr Jesper Svenningsen and Ms Maria José Costeira for the period from 19 September 2016 to 31 August 2022.

By decisions of 16 September 2015, 23 March 2016 and 24 May 2016, the terms of office of Mr Marc Jaeger, Mr Heikki Kanninen, Mr Savvas Papasavvas, Mr Sten Frimodt Nielsen, Mr Marc van der Woude, Mr Dimitrios Gratsias, Mr Juraj Schwarcz, Mr Viktor Kreuschitz and Mr Lauri Madise were renewed until 31 August 2022.

A formal sitting of the Court of Justice will take place today on the occasion of the taking of the oath of the new Advocate General and the new Judges called upon to take up office.
