**FORMAL SITTING FOR EULOGIES  
IN MEMORY OF FORMER MEMBERS OF THE COURT OF JUSTICE**

A formal sitting for memorial eulogies was held at noon today at the Court of Justice of the European Communities in Luxembourg.

In the course of the sitting, formal tribute was paid to the memory of

- **Robert Lecourt**, a Judge at the Court from 1962 to 1967 and President of the Court from 1967 to 1976, who died on 9 August 2004,
- **Ole Due**, a Judge at the Court from 1979 to 1988 and President of the Court from 1988 to 1994, who died on 21 January 2005, and
- **Pieter VerLoren van Themaat**, an Advocate General at the Court from 1981 to 1986, who died on 9 July 2004.

After an address by Mr Vassilios Skouris, President of the Court of Justice, the eulogies for Messrs Lecourt, Due and VerLoren van Themaat were delivered by Mr Pierre Pescatore, a former Judge at the Court of Justice, Mr Claus C. Gulmann, a Judge at the Court of Justice and Mr Leendert A. Geelhoed, First Advocate General at the Court of Justice, respectively.
