**ALL EUROPEAN FINAL OF THE EUROPEAN MOOT COURT COMPETITION
TAKES PLACE AT THE COURT OF JUSTICE OF THE EUROPEAN
COMMUNITIES, LUXEMBOURG ON 11 MARCH 2005**

Law students who have made their way through a tough selection among 94 teams since September when the competition was launched will today plead before panels composed of Members of the Court of Justice and Court of First Instance. The teams competing today represent 8 universities from 6 different countries.

They won their respective Regional Finals which were held in February in Madrid, Gothenburg, Istanbul and New York.

The Final is the last stage of this year's competition in the world's largest Moot Court in European law. The winners will receive various prizes, including internships with European Institutions or highly respected law firms specialised in European law.
