## NEW REGISTRAR OF THE COURT OF FIRST INSTANCE OF THE EUROPEAN COMMUNITIES

Mr Emmanuel Coulon has been appointed Registrar of the Court of First Instance of the European Communities by the Judges of the Court of First Instance for a term of six years, from 6 October 2005 to 5 October 2011.

He replaces Mr Hans Jung, who has been Registrar of the Court of First Instance since 10 October 1989.

At 18:00 hours today in Luxembourg, on the occasion of the departure of Mr Hans Jung, the Court of First Instance of the European Communities held a formal sitting at which Mr Emmanuel Coulon took the oath as Registrar of the Court of First Instance.

### Hans Jung

Born 1944; Assistant, and subsequently Assistant Lecturer at the Faculty of Law (Berlin); Rechtsanwalt (Frankfurt am Main); Lawyer-linguist at the Court of Justice; Legal Secretary at the Court of Justice in the Chambers of the President, Mr Kutscher, and subsequently in the Chambers of the German judge; Deputy Registrar at the Court of Justice; Registrar of the Court of First Instance from 10 October 1989 to 5 October 2005.

### Emmanuel Coulon

Born in 1968; law studies (université Panthéon-Assas, Paris); management studies (université Paris-Dauphine); College of Europe (1992); entrance examination to the Centre regional de formation à la profession d'avocat (Regional training centre for the Bar), Paris; certificate of admission to the Brussels Bar; practice as an avocat in Brussels; successful candidate in an open competition for the Commission of the European Communities; legal secretary at the Court of First Instance of the European Communities (Chambers of President Saggio, 1996-1998; Chambers of President Vesterdorf, 1998-2002); Head of Chambers of the President of the Court of First Instance (2003-2005); Registrar of the Court of First Instance since 6 October 2005.
