## FORMAL SITTING FOR THE SOLEMN UNDERTAKING OF THE MEMBERS OF THE EUROPEAN COURT OF AUDITORS FOLLOWING THE NEW ENLARGEMENT

The Council of the European Union, after consultation with the European Parliament, has appointed, by decision of 7 May 2004,<sup>1</sup> nine new Members of the Court of Auditors.<sup>2</sup>
