#### VISIT TO THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES BY A DELEGATION FROM THE CONSTITUTIONAL COURT OF BULGARIA

A delegation of five judges from the Constitutional Court of Bulgaria made an official visit to the Court of Justice on 7 June 2005.

On the occasion of this visit, the delegation took part in working sessions on the operation and organisation of the Court of Justice, references for a preliminary ruling and procedure before the Court of Justice in the presence of Mr L.A. Geelhoed, first Advocate General of the Court of Justice and Mrs N. Colneric, Judge at the Court of Justice; a working session was also held on the operation and organisation of the Court of First Instance in the presence of Mr M. Jaeger, President of Chamber at the Court of First Instance.

This meeting is organised in the context of the close, ongoing relations between the Court of Justice and the supreme courts of the accession States.
