#### **THE TERM OF OFFICE OF MR ROGER GRASS AS REGISTRAR OF THE COURT OF JUSTICE HAS BEEN RENEWED**

Mr Roger Grass, Registrar of the Court of Justice since 10 February 1994 whose second term of office will expire on 9 February 2006, had his term renewed on 28 June 2005 for the period from 10 February 2006 to 9 February 2012.

The Registrar of the Court is elected by the Judges and Advocates General for a term of six years. He is the Secretary General of the Institution whose departments he directs under the authority of the President of the Court.

Mr Roger Grass, a member of the French judiciary, has been inter alia Secretary General of the Cour d'Appel, Paris, member of the cabinet of the French Minister for Justice, and Legal Secretary at the Court of Justice in the chambers of Presidents Kutscher, Mertens de Wilmars, Lord Mackenzie Stuart and Due.
