DELIVERY OF JUDGMENT IN CASE C-112/05 SCHEDULED FOR 23RD OCTOBER 2007

Commission of the European Communities v Federal Republic of Germany

Judgment in Case C-112/05 Commission of the European Communities v Federal Republic of Germany will be delivered on 23 October 2007 at 9.30 a.m. in the Grande Salle of the Court of Justice.

An action against the Federal Republic of Germany was brought before the Court of Justice of the European Communities on 4 March 2005 by the Commission of the European Communities, claiming that the Volkswagen Law is an infringement of the free movement of capital and the freedom of establishment.

Specifically, the Commission criticises:

- The right of the Federal Republic and of the Land of Lower Saxony, as long as they are shareholders, to each appoint two members of the supervisory board of the company;
- The limitation of voting rights to 20% of the share capital where any shareholder exceeds that percentage; and
- The increase to more than 80% of the share capital represented for the adoption of certain resolutions of the general shareholders' meeting.

The hearing in this case took place on 12 December 2006, Advocate General Ruiz-Jarabo gave his opinion on the case on 13 February 2007.
