**ALL EUROPEAN FINAL OF THE EUROPEAN MOOT COURT COMPETITION
TAKES PLACE AT THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES,
LUXEMBOURG ON 4 APRIL 2008**

Law students who have made their way through a tough selection among 70 teams since September when the competition was launched, will today plead before panels composed of Members of the Court of Justice, Court of First Instance and Civil Service Tribunal of the European Union. The teams who are competing today represent six universities from different countries. They won their respective Regional Finals which were held in February and March 2008 in Maribor, Dallas, Valencia and Bangor.

Students from all over Europe participated in the competition. Those who made it to the Regional Finals also included students from the USA, Singapore, Pakistan and China.

The Final is the last stage of this year's competition in the world's largest Moot Court in European law. The winners will receive various prizes, including internships with European Institutions or highly respected law firms specialised in European law.
