NEW JUDGES AT THE COURT OF JUSTICE AND COURT OF FIRST INSTANCE OF THE EUROPEAN COMMUNITIES

Formal sitting of 12 January 2007 at 18:00 at the Court of Justice

Following the accession of the Republic of Bulgaria and of Romania to the European Union on 1 January 2007, the Representatives of the Governments of the Member States of the European Union have appointed as Judges of the Court of Justice of the European Communities: Mr Alexander Arabadjiev, for the period from 12 January 2007 to 6 October 2012, and Ms Camelia Toader, for the period from 12 January 2007 to 6 October 2009. The following persons have been appointed as Judges of the Court of First Instance of the European Communities: Mr Theodore Chipev, for the period from 12 January 2007 to 31 August 2007, and Mr Valeriu Ciucă, for the period from 12 January 2007 to 31 August 2010.

A formal sitting for the swearing of the oath and the taking up of duties of the four new Members will take place on:

Friday 12 January 2007, at 18:00 in the Grande Salle d’Audience (Main Court Room)

(entrance on Boulevard Konrad Adenauer, opposite the European Investment Bank).
