# NEW MEMBERS OF THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES AND OF THE COURT OF FIRST INSTANCE OF THE EUROPEAN COMMUNITIES

Formal Sitting on 6 October 2003 at 5 pm in the Court of Justice

The terms of office of a number of Members of the Court of Justice of the European Communities will expire on 5 October 2003.

By decision of 23 July 2003, the Representatives of the Governments of the Member States renewed certain terms of office and appointed new Members for the period 7 October 2003 to 6 October 2009.
