# Partial renewal of the membership of and entry into office of six new Members of the Court of Justice

By decision of 28 February 2018, the representatives of the governments of the Member States of the European Union renewed the term of office of eight Judges of the Court of Justice, namely Mr Alexander Arabadjiev, Mr Jean-Claude Bonichot, Mr Thomas von Danwitz, Mr Carl Gustav Fernlund, Mr Egils Levits, Mr Constantinos Lycourgos, Mr Jiří Malenovský and Ms Alexandra Prechal.

By decisions of 28 February 2018, 13 June 2018, 25 July 2018 and 5 September 2018, Ms Lucia Serena Rossi, who replaces Mr Antonio Tizzano, Mr Irmantas Jarukaitis, who replaces Mr Egidijus Jarašiūnas, Mr Peter George Xuereb, who replaces Mr Anthony Borg Barthet, and Mr Nuno José Cardoso da Silva Piçarra, who replaces Mr José Luís da Cruz Vilaça, were appointed as Judges of the Court of Justice for the period from 7 October 2018 to 6 October 2024.

By decision of 28 February 2018, the representatives of the governments of the Member States of the European Union renewed the term of office of two Advocates General of the Court of Justice, namely Mr Yves Bot and Mr Maciej Szpunar, for the period from 7 October 2018 to 6 October 2024.

By decisions of 28 February 2018 and 5 September 2018, Mr Giovanni Pitruzzella, who replaces Mr Paolo Mengozzi, and Mr Gerard Hogan were appointed as Advocates General of the Court of Justice for the period from 7 October 2018 to 6 October 2024.

On the occasion of the departure from office of Mr Antonio Tizzano, Mr José Luis da Cruz Vilaça, Mr Melchior Wathelet, Mr Anthony Borg Barthet, Mr Paolo Mengozzi and Mr Egidijus Jarašiūnas and the taking of the oath and entry into office of the new Members of the institution, a formal sitting of the Court of Justice of the European Union will take place today.

institutional, economic and social reforms and appointed by the Prime Minister, in June 2018, as a member of the group of experts called upon to propose a project of constitutional reform; author of numerous publications on public, constitutional, administrative and competition law; Advocate General at the Court of Justice since 8 October 2018.
