# New composition of the Chambers of the General Court of the European Union

Following the partial replacement of the Members of the General Court of the European Union, <sup>1</sup> and the election of the President, <sup>2</sup> the Vice-President, <sup>3</sup> the Presidents of Chambers <sup>4</sup> and the Judges called upon to perform the duties of an Advocate General in dealing with requests for a preliminary ruling, <sup>5</sup> the General Court amended, on 22 September 2025, the decision on the formation of Chambers and the assignment of Judges to Chambers, the decision on the composition of the Grand Chamber and the Intermediate Chamber, the decision concerning the criteria for allocation to Chambers, and the decision on the method of designating the Judge to replace a Judge who is prevented from acting.

For the period from 16 September 2025 to 31 August 2028, the General Court is composed of ten Chambers, seven of which are responsible for cases relating to intellectual property law and three of which are responsible for cases relating to the civil service. <sup>6</sup> The two Chambers responsible for requests for a preliminary ruling form part of the seven Chambers responsible for cases relating to intellectual property rights.
