**CELEBRATION OF THE TWENTIETH ANNIVERSARY OF THE COURT OF FIRST  
INSTANCE OF THE EUROPEAN COMMUNITIES**

*From 20 to 2020 – Building the CFI of tomorrow on solid foundations*

An event was organised today at the seat of the Court of Justice of the European Communities in Luxembourg to celebrate the twentieth anniversary of the Court of First Instance of the European Communities.

The celebrations were opened by welcome speeches given by Mr Vassilios Skouris, President of the Court of Justice, and by Mr Marc Jaeger, President of the Court of First Instance.

On the occasion of this celebration, workshops on the themes ‘Quality of justice’ and ‘Access to justice’ were held with the participation of representatives of European and international institutions, professors of law, judges and lawyers from all the Member States.

The day’s events were closed by a formal sitting graced with the presence of their Royal Highnesses the Grand Duke and the Hereditary Grand Duke. During that sitting, Mr François Biltgen, Minister for Justice of the Grand Duchy of Luxembourg, Mr Jean-Luc Dehaene, Member of the European Parliament, and Mr Marc Jaeger, President of the Court of First Instance, each gave a speech.
