The only differences between the judgments are accounted for by the appearance of the three-dimensional trade marks for which registration was sought, namely, in this case, the shape of a rectangular tablet with two layers, one white and the other green.

hereby:

1. Dismisses the action;
2. Orders the parties to bear their own costs.
