



INFORMATION NOTICE ON THE PROTECTION OF PERSONAL DATA

COURT OF JUSTICE OF THE EUROPEAN UNION

Everyone has the right to the protection of personal data.

The processing of personal data by the institutions, bodies, offices and agencies of the European Union is governed by Regulation 2018/1725 (OJ 2018 L 295, p. 39).

This notice explains how and why your data are used in the context of the processing operation concerned.

Who is the data controller?

The controller responsible for processing the data is the Accounting Officer of the Court of Justice of the European Union ('the Court' or 'the Institution').

Why do we need your data?

In accordance with Article 86(3) of Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, the departments of the accounting officer of the Court will keep your personal data in a register and will enter them in the Court's accounting and financial management system only in so far as this is necessary for the purpose of processing and accounting for any direct or indirect financial and contractual

¹ 'Third party' means an entity governed by public or by private law or a natural person with whom the Court of Justice of the European Union has a financial relationship. The personal data processed relate to identified or identifiable natural persons who represent such an entity or who themselves have a financial relationship with the Court of Justice of the European Union.



relationship that you have or may have with the Court.

How did we obtain your data?

Your personal data are collected by your contact person in the authorising department of the Court with whom you liaise, who transmits the data to the Court's accounts department for entry in the accounting and financial management system.

Who has access to your data?

The members of staff of the Institution responsible for accounting and financial management have access to your data, as do the auditors of the European Court of Auditors within the framework of the task entrusted to it by Article 287 TFEU.

How long are your data stored for?

In accordance with the document storage periods adopted by the Institution, personal data, whether in paper or in electronic form, are stored for a period of 10 years from the 1st of January following the year in which the last financial transaction with you was concluded.

Paper or electronic files are deleted in the year following the end of the storage period.

What are your rights?

In accordance with the applicable rules, you have the right to request from the controller access to your data and, if necessary, rectification of your data or restriction of processing.



How do you exercise your rights? Whom to contact?

European Data Protection Supervisor
