Implementation of Article 50b of the Statute of the Court of Justice of the European Union **(1/10/2024 – 30/06/2025)**

Following the entry into force of Regulation (EU, Euratom) 2024/2019 of the European Parliament and of the Council of 11 April 2024 amending Protocol No 3 on the Statute of the Court of Justice of the European Union ('the Statute'),¹ the jurisdiction of the Court of Justice to give preliminary rulings has been transferred in part to the General Court of the European Union. Since 1 October 2024, the General Court is the court having jurisdiction to hear and determine requests for a preliminary ruling that come exclusively within one or several of the specific areas referred to in the first paragraph of Article 50b of the Statute,² unless those requests raise independent questions relating to the interpretation of primary law, public international law, general principles of Union law, or the Charter of Fundamental Rights of the European Union, in which case those requests will be dealt with by the Court of Justice.

At the time of adoption of the regulation referred to above, the Court of Justice was invited by the EU legislature to publish, by 2 September 2025, a list of examples of the application of Article 50b of the Statute.³

The present document is intended to follow up on that invitation. The table set out in the annex reproduces all the requests for a preliminary ruling coming within one or several of the specific areas referred to in the first paragraph of Article 50b of the Statute that have been lodged with the Court of Justice between 1 October 2024 and 30 June 2025 and indicates, in the last column, the reasons why some of those requests have not been transmitted to the General Court and are being dealt with by the Court of Justice (either because they cover areas other than the specific areas referred to above, or because they raise one or several independent questions relating to the interpretation of Union law).

² As a reminder, the six areas in question are as follows: (1) the common system of value added tax, (2) excise duties, (3) the Customs Code, (4) the tariff classification of goods under the Combined Nomenclature, (5) compensation and assistance to passengers in the event of denied boarding or of delay or cancellation of transport services, and (6) the system for greenhouse gas emission allowance trading.
